## To the members:

During the past few days I have thought about this particular topic ( "the future of engineering team dynamics" by Dwight Hamilton in the *Professional Engineers of Ontario, September-October 2002 issue of "Engineering Dimensions"*

at= <http://www.peo.on.ca/> Click on PUBLICATIONS (left bar) then ENGINEERING DIMENSION - CURRENT ISSUE, and then FUTURE TEAM), and have read others comments offered, and I would like to offer a few observations:

My perception is that the opportunities, status and acceptance of all Technicians and Technologist have be raised in the past few years. I believe that the main reason for this is due to the high quality training of 'competency' within nationally accredited programs of community colleges across the country, which include both technical and practical components. In the end, this has served industry (as well as the Technicians and Technologists) by providing graduates from these programs with an excellent technical foundation while empowering them with a "Can Do" attitude, which results from both the technical skills and the practical experience gained from these training programs. The provincial certifying associations/Societies accredit the technology programs in a nationally accepted and 'interprovincial team' process to ensure they meet Canadian Technology Standards (CTS). Furthermore, I have had specific experience acting as an employer's representative to review the Electronic Engineering Technology program at NBCC Moncton. I think another major reason for the success of the Technology programs, is employers have the opportunity to have input into the programs by participating in the college's Program Advisory Groups/Committees, to ensure graduates will have the training and tools to contribute as employees.

My specific issue here is that if provincial Technician/Technology Societies cease to exist who will perform this function? Maybe the professional engineering associations? Possibly; however, it's also possible in that case the engineering associations will design the programs to suit their particular programs, adapting the training to accord with what THEY think a technician or technologist should be. In this scenario, I think all Technicians and Technologists would lose the ability of self determination.

Based on this illustration I do not support the loss of any provincial society or certifying association; but instead, as others have stated, support the stand that provincial engineering associations "recognize" the PEO's Task Force Report/Recommendations, of a designation in conjunction with provincial Technician/Technology associations. I believe that provincial professional engineering organizations can work with the provincial Technologists/Technicians associations, in considering the CTS, the certifying standards, and nationally accredited college programs curriculums, to determine minimum requirements to meet this designation. In doing this, these requirements could be incorporated into the

Technology programs, or more likely, additional courses, which would be developed and offered to meet the requirements outside of the original college programs, and which could be accredited by the applicable professional engineering associations.

**I think there are benefits to be gained by all parties by "limited licensing". However, I also think that giving up our own organization, and the ability to guide ourselves, is an extremely high price which Technologists/Technicians, present and future, can not afford to pay.**

I would appreciate any comments or views related to the above.

**Travel Advisory: Non-Canadians travelling to USA**

Dear Executive;

The following information is provided to alert you to a change in policy for Canadian residents, but non-citizens who may be traveling to the USA in the coming weeks. The Embassy of the United States of America has identified that **beginning December 16, 2002** all landed immigrants in Canada must possess a valid passport and non-immigrant visa to enter the United States. This requirement will apply to citizens of the following Commonwealth countries who were formerly exempt from visa requirements: Antigua and Bermuda; Australia; Bahamas; Bangladesh; Barbados; Belize; Botswana; Brunei; Cameroon; Cyprus; Dominica; Gambia; Ghana; Grenada; Guyana; India; Ireland; Jamaica; Kenya; Kiribati; Lesotho; Malawi; Malaysia; Malta; Mauritius; Namibia; Nauru; Nigeria; New Zealand; Pakistan; Papua New Guinea; St. Kitts & Nevis; Seychelles; St. Lucia; St. Vincent & the Grenadines; Sierra Leone; Singapore; Solomon Islands; South Africa; Sri Lanka; Swaziland; Tanzania; Tonga; Trinidad & Tobago; Tuvalu; Uganda; United Kingdom (its colonies, territories and dependencies); Vanuatu; Western Samoa; Zambia; Zimbabwe. ## Software Project Management

Continuing Education Course (4063) - 298974

**Web-Based Course** -January 20 - April 7, 2003

Monday Evenings, 6:00 - 7:30 p.m.

Project Management, or the success of project managers, will often have a more significant impact on the overall success of a project than any other component (i.e., selection of the appropriate technology, technical and/or programming skills of the project team or complexity of the chosen application). Project Management is where organizations encounter the most serious problems, and where there is the best opportunity for significant improvement. This course will focus on the project management process and help the participant understand the task of managing the software process to better understand the essential components of project management and how it can be improved in any organization.

The primary audience is anyone who is involved in project management, from

small team leaders for 2-5 people to a project director for a major initiative. A secondary audience includes anyone who is managed by a project manager; they need to understand project management as they are affected by it. A third audience would be key user acceptors as it is also critical for them to understand the project management process and how it will affect them as the process is implemented. **The primary teaching mode will be web-based**, using a system called WebCT. Course materials will be accessed through a class web site, which also supports discussion groups with other students and allows for email interaction with the instructor. In addition to the web-based component, students will meet once a week for an audio-conference session from 6:00 - 7:30 p.m. Students in Halifax will meet with the instructor at Continuing Technical Education, 5269 Morris Street, while students in other areas can join from their home or workplace.

## ONLINE EMPLOYEE SKILLS EVALUATION PROGRAM LAUNCHED

**World-first tool for standards-based self-assessment to be offered at the Canadian Technology Human Resources Board (CTHRB) National conference**

Canadian employees and companies will soon have access to a self-assessment program that allows employees to record and validate their skills online to industry standards, said Bob Cook, Executive Director of the Canadian Technology Human Resources Board (CTHRB). "The PROfile online self-assessment program offers Canadian individuals and companies unique competitive advantages," stated Mr. Cook. "Canadian employees will now be able to identify skills and competencies that they have acquired through education and workplace experiences. This will allow them to be credited for knowledge they possess that would otherwise have required a formal certificate or training program. By allowing them to assess their own competencies according to National Technology Standards, the PROfile program rewards employees for the intrinsic knowledge they have gained over the years. **For employers, PROfile provides the latest skill-set information on employees, allowing employers to identify the real levels of achievement for those key people within their organizations, and thereby give a better match between job requirements and employee skills. This is hugely important — in Canada, the mismatch between skills and job requirements is estimated to cost firms \$2-billion a year. Further, in today's market of extreme skill shortages for certain types of technicians, employers will be better able to find the right people for the right job.**" PROfile was launched at the CTHRb's 1<sup>st</sup> National Conference, "Tapping Our Collective Potential", Quebec City, Oct. 27-30.

By providing new tools that address skills' shortages issues, backed by success stories of those who have resolved these challenges, Mr. Cook indicated that PROfile meets the call from the Minister of Human Resources to ensure that all sectors of Canadian society to ensure we meet our skills and learning requirements for the 21st century. It's an ultra-competitive world right now," concluded Mr. Cook. "Companies need to have exactly the right skill set at their command. PROfile allows them to find the "Gold Standard" of employee training."
